

## WebEDI Pricing Summary

### ONE SIMPLE, ALL-INCLUSIVE PRICING STRUCTURE

- ✓ Pay for only what you use. No over limit fees
- ✓ Free WebEDI Product Catalog feature (allows for the ASN Auto-pack feature)
- ✓ Free UCC 128 shipping labels (if required). No cost for set up or printing.
- ✓ Monthly terms. No long-term contract requirements
- ✓ 997 (functional acknowledgments) are not counted as transactions. No charge.

#### Trading Partner Setup Fee (One time fee per partner)

**\$150**

Each trading partner setup requires a one-time fee of \$150 (in network). This pricing applies to standard trading partners in the Compliance Networks network. Additional mapping fees may be required for out of network partners. Includes WebEDI account set up, WebEDI training, on-line tutorial tools and documentation, full EDI implementation, EDI set up support, trading partner required shipping labels and EDI transaction sets.

#### Monthly WebEDI Account Fee

**\$35/mo.**

Customers will be billed the monthly WebEDI account fee (which includes 20 transactions per month) plus transaction fees based on volume in the previous month.

#### Monthly Transaction Fees

0-20	\$ 0	\$35 (up to 20 transactions)
21-100	\$ 0.70	+\$56 (+80 trans.)
101-250	\$ 0.60	+\$90 (+150 trans.)

501-1000	\$ 0.40	+\$200 (+500 trans.)
1001-2000	\$ 0.30	+\$300 (+1000 trans.)
Over 2000	\$ 0.20	TBD

\*Monthly Trading Partner Fee : The transaction fee above includes the 1<sup>st</sup> trading partner. Additional Trading Partners added to the account are \$5 per month per trading partner.

### Optional Services

Custom Mapping/Development: All custom development work, custom mapping work, optional transaction sets, etc.: \$130/hour.

Compliance Networks WebEDI Integrator Options: QuickBooks and Peachtree Integrators (\$500 Setup + \$25/mo.) All other integration options require Compliance Networks WebEDI Advanced. Please speak with your Compliance Networks Representative about WebEDI Advanced.

#### Pricing Example

Example 1: One trading partner and the monthly volume is 25 documents (PO's, Invoices, ASN's, etc). The initial setup fee will be \$150 and the total monthly fee will be:

Monthly WebEDI Account Fee-	\$ 35.00
0-20 Documents	\$ 0.00
21-25 Documents (5 x \$0.70)	\$ 3.50
<b>Total Monthly Fee</b>	<b>\$ 38.50</b>

Example 2: Three trading partners and the monthly volume is 175 documents. The initial setup fee will be \$450 (3 x \$150)

Monthly WebEDI Account Fee-	\$ 35.00
0-20 Documents	\$ 0.00
21-100 Documents (80 x \$0.70)	\$ 56.00
101-175 Documents (75 x \$0.60)	\$ 45.00
2 additional Trading Partners (\$5 x 2)	\$ 10.00
<b>Total Monthly Fee</b>	<b>\$146.00</b>
